TARGET SPECIES:

Cattle. Swine.

INDICATIONS:

Mineral supplement.

Adjuvant in cases of decreased fertility, hypothyroidism, anemia, osteopathy (spontaneous fractures in calves, joint deformities). Coadjuvant when it is necessary to increase copper, iodine, cobalt, and manganese during pregnancy, lactation, growth, fattening, convalescence, parturition and pre-service, pre- and post-weaning.

White plastic bottle with label.

Content: 250 and 500 ml.

APPEARANCE:

Clear solution, violet coloration.

DOSAGE AND ADMINISTRATION:

Cattle:

Calves up to 200 kg b.w.: 1 ml every 50 kg b.w.

Steers and heifers: 5 ml per animal as a total dose.

Cows: 6 ml as a total dose.

Bulls: 8 ml as a total dose.

Swine:

0.5 ml every 25 kg b.w., applying a maximum of 2 ml.

Route of administration: Subcutaneous injection.

Hypersensitivity to any of the components of the product.

SIDE EFFECTS:

None observed when respecting the indicated doses.

PRECAUTIONS:

Strictly respect the proposed dosage. Prior determination of mineral deficiency type is suggested. Do not apply to tired or exhausted animals. In such case, let them rest before application. Avoid increasing dosage in young animals. Ensure asepsis during injectable administration. Allow 30 days between application and slaughter for human consumption. Do not mix with other products.
