## TECHNICAL DATA SHEET

### FORMULA:

Artichoke tincture	4.00 ml
Boldo tincture	4.00 ml
Carqueja tincture	4.00 ml
DL-Methionine	1.20 g
Sorbitol	50.00 g
Formulation agents q.s. to	100 ml

### TARGET SPECIES:

Equines.

### INDICATIONS:

It is an adjuvant in liver detoxification treatments composed of natural tinctures of artichoke, boldus, and carqueja, plus Sorbitol and an amino acid such as DL-Methionine. HEPATOFIELD is used as a complement in liver protection therapies and promotes the production of bile (choleric) and its passage to the intestine (cholagogue), aiding digestion.

### PRESENTATION:

Opaque high-density polypropylene containers of 120 ml, 500 ml, 1000 ml, and 5000 ml.

### APPEARANCE:

Clear viscous brown solution.

### DOSAGE AND ADMINISTRATION:

Administer orally.

EQUINES: 5 ml per 100 kg b.w. every 12 h.

### CONTRAINDICATIONS:

Do not administer to animals with hypersensitivity to any of the formulation components.

Do not use in pregnant females (last third) or during lactation.

Do not use in cases of gallstones or bile duct obstruction.

May cause excessive stool softening, which resolves upon discontinuation of the product.

### SIDE EFFECTS:

At the indicated doses, no side effects were observed.
