Downer cattle due to hypomagnesemia or hypocalcemia: intravenous application of up to 50 ml per 100 kg b.w., or according to veterinarian's discretion.

Parenteral application:

- Cattle, sheep, swine, goats: subcutaneous, intramuscular, or slow intravenous.
- Horses: Slow intravenous is preferred. Intramuscular divided into 2 sites.

CONTRAINDICATIONS:

Hypersensitivity to any of the components of the product.

None observed.
